Porting request maybe declined/rejected by the losing carrier, your existing provider, Anveo or Anveo's carrier at any time during porting process. You acknowledge and agree to hold harmless Anveo from and against any damages or liabilities of any kind related to porting of the phone number. After the phone number is ported your account will be charged phone number setup fee and 1st month subscription according to Anveo Phone Number rate plan selected above. During the porting process our carrier might request some additional information and you agree to provide it in a timely manner otherwise the porting request will be canceled.
