A porting process takes 3-6 weeks on average to complete; however in some cases it may take longer. You must maintain active service with your current provider until after the number is successfully ported to Anveo. The porting request may be declined/rejected by the losing carrier, your existing provider, Anveo or Anveo's carrier at any time during the porting process. You acknowledge and agree to hold harmless Anveo from and against any damages or liabilities of any kind related to the porting of a phone number. After the phone number is ported, your account will be charged the phone number setup fee and 1st month subscription according to the Anveo Phone Number rate plan selected above. During the porting process, our carrier might request some additional information and you agree to provide it in a timely manner, otherwise the porting request will be cancelled.

** Free Porting Specific Terms: When the FREE porting is complete the phone number will be pre-paid for 12 months and account will be charged a non-refundable \$24 (12 x \$2/month) for Personal Unlimited rate plan, or \$48 (12 x \$4/month) for Office Unlimited rate plan. If the porting request was not complete (for example you canceled the request or you failed to provide information required to complete the porting in a timely manner), the regular \$15 non-refundable porting fee will be charged.
